PRIVACY STATEMENT

General

This privacy statement explains how Driscoll's du Maroc S.A.R.L. (hereinafter also referred to as: 'Driscoll's', 'we', 'us' or 'our') deals with personal information that is obtained with regards to the cooperation between you and us. We respect your privacy and ensure that any personal information we receive will be protected and treated confidentially.

Collection and use of personal data of growers, nurseries and landowners

In case you are a grower, nursery or landowner, we may collect the following personal data in order to draft the Grower Agreement, Nursery Agreement and/or Landowner Covenant needed for our cooperation:

- Full name;
- Job title;
- Address;
- ID number;
- E-mail address;
- Telephone number; and
- Bank account number.

We use this information solely for the purpose of drafting and executing the agreement between you and us or in the event we have a legitimate interest or legal obligation. Without processing these personal data, we will unfortunately be unable to cooperate with you.

Collection and use of personal data of vendors

In case you are a vendor, we may collect the following personal data for the performance of the agreement we concluded with you:

- Name;
- Telephone number; and
- E-mail address.

We use this information among other things for maintaining necessary contact with you. Without processing these personal data, we will unfortunately be unable to cooperate with you.

Information disclosure

We may provide your information to third parties for the following purposes:

- to other Driscoll's entities, for the purpose of executing agreements ;
- to carriers, for (plant) transportation purposes;
- to our clients, such as distributors or customers, for example when they request us to provide them with information in order to be able to perform a quality or safety check;
- IT service providers, in order to be able to store and/or otherwise process relevant data in our systems;
- in instances where we are required or allowed by law (including a regulatory body) to disclose this information, for example when cooperating with government or law enforcement officials or to respond to legal claims; and
- when we are involved in a bankruptcy, merger, acquisition, reorganization or sale of assets, your personal information may be transferred to a third party as part of the transaction.

In most cases mentioned above, the information will be shared in order to be able to perform the agreement with you or we will have a legitimate interest to share your personal information with third parties. In all other cases, we will ask your consent before sharing your personal information with third parties. Please note that you have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on this consent prior to your withdrawal.

International data transfer

Your personal information will be maintained on servers located within the EU and the US. Personal data will be transferred and/or stored to the US under the applicable Privacy Shield. Some of your personal information may be shared with Driscoll's of Europe.

Your rights

You have the right to request an overview of your personal information that we have registered. Furthermore, you have the right to request modification of incorrect personal information. You may also request the removal of your personal information and object to or ask to restrict further processing of your personal data. In some cases you may have the right to data portability as well. You may send requests regarding the aforementioned to: info@driscolls.eu.

In case of any of these requests, we may ask you to provide us with a copy of an ID card or any other form of identification in order to avoid abuse of your identity.

We will respond to any appropriate request within the time period specified by law. If we fail to comply with one of the aforementioned requests, you will have the right to file a complaint with the Data Protection Authority.

Retention period

We will retain your personal information for the period necessary to fulfil the purposes outlined in this privacy statement unless a longer retention period is required or permitted by law.

Security measures

We take reasonable administrative, physical and electronic measures designed to protect the information that we collect from or about you (including your personal and organisational information) from unauthorized access, use or disclosure.

Changes to this privacy statement

We may revise this privacy statement from time to time. If we make changes to this privacy statement that, in our sole discretion, is material, we will try to notify you of those changes and we will update the “last updated” date above.
